LISTON and DESSIE MAE LISTON, of the County of Kaufman, State of Texas, for and in consideration of the sum of Ten Dollars and other good and valuable considerations, to us in hand paid by BARBARA ANN LISTON RASOR and CHARLES FRANK RASOR, receipt of which is hereby acknowledged, have Granted, Sold and Conveyed, and by these presents do Grant, Sell and Convey unto the said BARBARA ANN LISTON RASOR and CHARLES FRANK RASOR, of the County of Kaufman, State of Texas, all that certain lot, tract or parcel of land lying and being situated in the County of Kaufman, State of Texas, and being a part of the Joseph M. H. Chisholm Survey, Patent No. 140, Vol. 35, Abstract No. 105, and described as follows:

BEGINNING at a point in the East right-of-way line of F.M. Highway No. 986, said point being the most Southwesterly corner of the Richard R. Ramsey tract of land; said point also being a perpendicular distance of 40 feet, more or less, from the center line of said F.M. Highway No. 986 right-of-way; said point also being a distance of 363.7 feet, more or less, in a Southwesterly direction from the point of curvature at Station 78#18.7 in said F.M. Highway No. 986 as described by the Texas Highway Department Deed recorded and filed on December 7, 1949, in Vol. 323, Pages 1-16, in Kaufman County, Texas; the said point of beginning having an iron pin for corner;  
THENCE South 45 deg. 00'E for a distance of 515.00 feet, more or less, to a point; said point being in the South line of the Richard R. Ramsey tract of land; said point also being in the North line of the Arthur L. Liston tract of land; iron pin for corner;  
THENCE South 45 deg. 00' West for a distance of 265.00 feet, more or less, to a point; iron pin for corner;  
THENCE North 45 deg. 47' West for a distance of 472.13 feet, more or less, to a point; said point being in the East right-of-way line of said F.M. Highway No. 986; iron pin for corner;  
THENCE North 36 deg. 03'E with East right-of-way line of said F.M. Highway 986 for a distance of 275.00 feet, more or less, to the point of beginning, and containing 3.041 acres of land, more or less.

TO HAVE AND TO HOLD the above described premises, together with all and singular, the rights and appurtenances thereto in anywise belonging unto the said BARBARA ANN LISTON RASOR and CHARLES FRANK RASOR, their heirs and assigns forever; and we do hereby bind
