

RESOLUTION NO. 2014

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS, ACCEPTING THE ELECTION RETURNS AS CERTIFIED BY THE KAUFMAN COUNTY ELECTION OFFICIAL AND DECLARING THE RESULTS OF THE JOINT ELECTION HELD ON MAY 7, 2022, IN TERRELL TEXAS, FOR THE PURPOSE OF ELECTING THE MAYOR OF THE CITY OF TERRELL, TEXAS, TO SERVE A THREE (3) YEAR TERM

WHEREAS, the City Council of the City of Terrell, Texas, adopted a Resolution calling a Joint Election to be held in said City on May 7, 2022, for the purpose of electing the mayor of the City of Terrell, Texas; and

WHEREAS, the Mayor is to be elected for a term of three (3) years; and

WHEREAS, said Joint Election was duly held at the time and at the place specified in the Resolution after due notice as required by law had been given; and

WHEREAS, there were a total of 943 ballots cast for the Mayor of the City of Terrell, Texas at said Joint Election; and

WHEREAS, only the qualified electors of the City of Terrell, Texas, were allowed to vote in said election.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS, THAT:

The Joint Election scheduled for May 7, 2022, was duly called and notice was given in accordance with the law and in accordance with the Resolution calling for said Joint Election.

The Joint Election was held in accordance with applicable state statutes and ordinances of the City of Terrell, Texas, and the following votes were cast in the respective places designated.




