

RESOLUTION NO. 2026

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS, SETTING A DATE, TIME AND LOCATION FOR A PUBLIC HEARING TO CONSIDER APPROVAL OF THE PROPOSED FISCAL YEAR 2022-2023 BUDGET FOR THE CITY OF TERRELL, TEXAS; DIRECTING THE CITY SECRETARY TO PUBLISH NOTICE OF SUCH PUBLIC HEARING IN A NEWSPAPER OF GENERAL CIRCULATION AND ON THE CITY INTERNET WEBSITE; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, City Council of the City of Terrell has prepared a proposed budget for Fiscal Year 2022-2023 for the City of Terrell, Texas; and

WHEREAS, the City Council is required to set a public hearing to consider the proposed budget for Fiscal Year 2022-2023 and will receive comments from the public for or against said budget.

THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TERRELL, TEXAS:

SECTION 1.

That the above recitals are found to be true and correct and they are incorporated herein as findings of the City Council for all purposes.

SECTION 2.

That the City Council of the City of Terrell shall hold a public hearing on the proposed Fiscal Year 2022-2023 budget for the City of Terrell; the public hearing to occur on Tuesday, September 6, 2022, at 6:00 o'clock p.m. to be held in the Council Chambers, Terrell City Hall, 201 East Nash Street, Terrell, Texas. All interested persons shall have the right to appear and be heard on the proposed Fiscal Year 2022-2023 budget.

SECTION 3.

That the City Secretary of the City of Terrell is hereby authorized and directed to cause notice of the public hearing to be published in a newspaper of general circulation in Kaufman County, Texas, not more than twenty (20) days nor less than ten (10) days prior to the date of such public hearing and on the City internet website.

SECTION 4.

All interested person may attend to express your support for or in opposition to the proposed Fiscal Year 2022-2023 budget by contacting members of the City Council of the City of Terrell at their offices or by attending the public hearing.

SECTION 5.


That this Resolution shall take effect immediately upon execution by the Mayor.
