

ORDINANCE NO. 3061

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TERRELL, KAUFMAN COUNTY, TEXAS, AMENDING APPENDIX 1, FEE SCHEDULE ORDINANCE OF THE CITY OF TERRELL BY UPDATING SECTION 6, BUILDING PERMIT AND DEVELOPMENT FEES AND CHARGES; PROVIDING FOR THE REPEAL OF ALL PREVIOUS OUTDATED AND CONFLICTING FEE SCHEDULES; PROVIDING FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the current fee schedule for Building Permit and Development Fees and Charges is outdated and insufficient to recover administrative costs associated with personnel and materials; and

WHEREAS, the City of Terrell desires to continue providing customer service related to these services; and

WHEREAS, the City Council, after careful consideration of the matter, hereby finds and declares that all Building Permit and Development Fees and Charges imposed upon residential and non-residential development should be equitable without imposing an unfair burden on such development and are in the best interest of the general welfare of the City and its residents by providing continued service;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TERRELL, KAUFMAN COUNTY, TEXAS:

ARTICLE I

THAT Appendix 1, Fee Schedule Ordinance of the City of Terrell, Section 6, Building Permit and Development Fees and Charges be amended and updated as follows:

Section 6. Building Permit and Development Fees and Charges

The following Fee Schedule shall be the official Development Fee Schedule for the City of Terrell:

A. Basic building permit fees:

C. Work Exempt from Permits:

1. The repair or replacement of an existing fence in a residential district in which approved materials are used and all other requirements are met (permit required but at no charge for fence replacement).
2. Roof repairs in which less than 10% of the roof area is involved.
3. Cosmetic improvements such as painting, cabinets, counter-tops, tile, non-structural repairs, replacement of wall materials involving less than 10% of any wall, or floor covering installation such as carpet, etc.
4. Appliance installation which does not require the device to have additional electrical, gas, or plumbing services installed.
5. prefabricated above ground swimming pools which are less than 24-inches deep and do not exceed 5,000 gallons.
6. Retaining walls less than 4-feet tall.
7. Playground equipment in residential districts.
8. Exemptions from permit requirements shall not be deemed to grant authority to perform any work that is in any manner in violation of City or State Codes.

ARTICLE II

All Ordinances or parts of Ordinances in conflict herewith are to the extent of such conflict hereby repealed.

ARTICLE III

It is hereby declared to be the intention of the City Council of the City of Terrell, Texas that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such as unconstitutionality shall not effect any of the remaining phrases, clauses, sentences, paragraphs and sections.

ARTICLE IV

All other provisions of Appendix 1, not expressly modified by this Ordinance shall remain in full force and effect.

ARTICLE V

This Ordinance shall take effect immediately after its passage and the publication of the caption as the law in such cases provides.






