

## ORDINANCE NO. 3122

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF TERRELL,  
KAUFMAN COUNTY, TEXAS, AMENDING APPENDIX 1, FEE SCHEDULE  
ORDINANCE OF THE CITY OF TERRELL BY UPDATING SECTION 12,  
EXCAVATION PERMIT FEES AND SECTION 13, RIGHTS-OF-WAY  
CONSTRUCTION PERMIT FEE; PROVIDING FOR THE REPEAL OF ALL  
PREVIOUS OUTDATED AND CONFLICTING FEE SCHEDULES; PROVIDING  
FOR SEVERABILITY AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, the City of Terrell, Texas, regulates construction, excavation, and utility work within public right-of-way and easements to ensure public safety and protection of infrastructure; and

**WHEREAS**, the City incurs costs related to review, inspection, and administration of excavation permits;

**WHEREAS**, the City Council has determined it necessary to amend the excavation fee schedule to reflect the actual cost of services and ensure effective oversight;

**NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF TERRELL, KAUFMAN COUNTY, TEXAS:**

### **ARTICLE I AMENDMENTS**

Appendix 1 of the Code of Ordinances of the City of Terrell, Texas, titled “Fee Schedule”, Section 12, “Excavation permit fees” is hereby amended to read as follows:

#### **Section 12. Excavation Permit Fees**

The following fees shall be charged to cover inspection and administrative costs related to all permits issued for the making of excavations within the public rights-of-way of the City of Terrell:

Base Excavation Permit Fee (per location)	\$75
Utility Line Installation – Linear foot fee (per foot)	\$1.00 (\$75 minimum)
Emergency Excavation Notification	No fee, permit required within 48-hours
Re-inspection Fee (each re-inspection)	\$50
Permit Renewal or Extension (per request)	\$250
Bore / Trench Under Public Street (additional fee)	\$250

Street, Sidewalk, or Curb Impact Inspection Fee	\$100
Noncompliance Work Without Permit (penalty fee)	Double standard fee amount

**Section 13. Right-of-way construction permit fee**

Delete in its entirety; See Section 42 – City Department(s) Recoverable Costs

**ARTICLE II**

All Ordinances or parts of Ordinances in conflict herewith are to the extent of such conflict hereby repealed.

**ARTICLE III**

It is hereby declared to be the intention of the City Council of the City of Terrell, Texas that the sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable and, if any phrase, clause, sentence, paragraph, or section of this Ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such as unconstitutionality shall not effect any of the remaining phrases, clauses, sentences, paragraphs and sections.

**ARTICLE IV**


All other provisions of Appendix 1, not expressly modified by this Ordinance shall remain in full force and effect.

This Ordinance shall take effect immediately after its passage and the publication of the caption as the law in such cases provides.




